Did you know that you can redirect your tax dollars to a Catholic School of your choice?

Individuals

Individuals with a tax liability can now join a Special Purpose Entity (SPE) to take full advantage of the PA EITC programs.

- Use the credit on personal PA taxes
- 90% tax credit for a 2-year commitment
- Currently recruiting members
- Designate to a Catholic school of your choice

Businesses

PA businesses can contribute up to \$750K. C-Corps, S-Corps, LLCs and Limited Partnership are eligible to participate.

- Available to businesses in PA
- Receive a 75% credit for 1-year commitment or 90% credit for 2-years
- New businesses can apply by July 1st
- Designate to a Catholic school of your choice

You Can Redirect Your Tax Dollars to Support Catholic Education

Just follow these three easy steps:

- 1.) Contact an approved scholarship organization of your choice like BLOCS or the Foundation for Catholic Education, and complete the necessary forms to enroll in the program. Applications are accepted beginning July 1st, so you can start the application process now.
- 2.) Once you receive your approval, make a donation to the scholarship organization within 60 days. Make sure to designate your donation to one of the 119 Archdiocesan elementary schools, 17 Archdiocesan high schools, four special education schools or one of the 15 Independence Mission Schools.
- 3.) Submit the paperwork provided by the state with your state taxes to receive your tax credit. You can even claim the donation on your federal taxes. Don't forget to consult your tax advisor so you can maximize your benefits. Get Started Today! Contact one of these approved scholarship organizations!
