*Note: Clearances 1-3 must be renewed every five years in accordance with State and Archdiocesan policies. The school must have a copy of clearances on file.*

<p><b>2. PA Child Abuse Clearance</b> <a href="https://www.compass.state.pa.us/CWIS">https://www.compass.state.pa.us/CWIS</a> Create an "Individual Account" to access the application. <p><b>3. PA Disclosure Form</b> This <a href="#">form</a> is required for volunteers who have been residents of PA for the past 10 years.</p> <p><b>OR</b></p> <p><b>Federal Fingerprint Check (FBI)</b> <a href="https://uenroll.identogo.com/">https://uenroll.identogo.com/</a> Required for volunteers who have not been residents of PA for the past 10 years and for employees. Schedule an appointment. When accessing the "unofficial" results via email, make sure you can print because the unofficial result can only be accessed once.</p>	<p>Required for volunteers who are residents of PA for the past 10 years.</p> <p>Required for volunteers who are not residents of PA for the past 10 years. <p><b>5. Protecting God's Children (Safe Environment Training Part 1)</b> This training is held at a location throughout the Diocese. Register for a class via <a href="http://virtusonline.org/virtus/">http://virtusonline.org/virtus/</a> Look for the "First Time Registrant" tab on the left side of screen to get started. You will be able to search available classes before registering. Training is approximately two hours.</p>	Required for Regular Volunteers	Required
<p><b>6. Mandated Reporter Training (Safe Environment Training Part 2)</b> This training is completed online: <a href="https://learning.childyouthprotection.org/login/index.php">https://learning.childyouthprotection.org/login/index.php</a> Register/Create an account and complete the training, which takes about one hour. You will be able to print a certificate of completion at the end of the course.</p>	Required for Regular Volunteers	Required
